WE DO NOT CONSENT To the unlawful and disproportionate COVID-19 lockdown

- More people have suffered and died due to the lockdown than from COVID19. 75,600 excess deaths and counting largely due to suicides, domestic abuse and postponed cancer treatments.
- As of 19 March 2020, COVID-19 is no longer considered to be a high consequence infectious disease in the UK (www.gov.uk/guidance/high-consequence-infectious-diseases-hcid).
- There is no scientific evidence that social distancing is effective at reducing transmission.
- COVID19 has a recovery rate of 98.6% and it is harmless to the majority of people including those in the vulnerable groups. This high recovery rate increases daily with more positive tests, but no corresponding increase in mortality.
- SARS-CoV-2 has not been isolated and tested using Koch's Postulates, the gold standard procedure that establishes a causative relationship between a microbe and a disease.
- The death rates from COVID19 are lower than the flu deaths of previous years. Why haven't governments and WHO locked down the whole world before?
- Face masks do not work, as advised by the WHO for the first 3 months of the restrictions. Masks are harmful when worn for hours and reused. Masks collect germs that will be repeatedly inhaled rather than expelled. Masks lower oxygen uptake and cause hypercapnia (high carbon dioxide in the blood). This can lead to feeling dizzy, fainting, mental confusion and increased susceptibility to infections. Masks cannot prevent the inhalation of viral-sized particles. Coronaviruses are usually 0.0005 mm in size.
- Since the lockdown in March, UK jobless claims have increased by 125.9%, reaching a staggering 2.8 million (statistic on May 2020).
- The government policy does not resemble a well-being plan, but rather a control and profit agenda. No real health and immune system boosting advice has been given around COVID19, with attention focused solely on the development of a vaccine.
- Whilst under lockdown, illegal and uninsured 5G masts and related infrastructure have been fervently installed, under the guise of 'essential works.' No company will insure 5G masts because of the adverse health effects associated with 5G. More than 500 studies have found harmful biologic health effects from exposure to low levels of Radio Frequency Radiation associated with 5G networks (5gappeal.eu, bioinitiative.org).

- We have lost our fundamental rights and freedoms with unlawful lockdowns. Further lockdowns are happening in the UK and around the world. We want our freedom to operate businesses, to gather, to travel, to work, to worship, to speak freely and have a family and social life.
- The Government's defence during the judicial review of the lockdown stated that schools were not ordered to close and that the government would not accept liability for any harm to students as a result of the lockdown. Italy reported that 99% killed by coronavirus had predisposing conditions and very elderly. Many of the diagnostic tests in the UK and elsewhere in the world were double-counted, inflating the number of COVID19 cases and thus pushing more strict and unnecessary lockdowns.
- **The WHO on the 9th of June announced that transmission of the virus from asymptomatic people is rare. CDC stated that transmission of the virus from surfaces is rare.**
- Shops have been urged to reject cash, claiming that it transmits the virus, whilst e-commerce deliveries, newspapers, food packaging etc is not considered a risk, in spite of the many opportunities for contamination involved in manufacture and distribution.
- A cashless society rapidly threatens, discriminating against the elderly population, further depressing the economy, and may even herald the social credit system of China. The economic crash due to the unlawful and unnecessary lockdowns sees the world's economy at the worst it has been in 8 decades. Suicide and crime rates are bound to increase.
